


Instructions for Online Enrollment (PCA/Worker)

Completing enrollment online is fast and easy! Please follow these instructions to complete your online enrollment.


1. Check your email for an Enrollment Request email from support@palcofirst.com.
2. Click the encrypted link to access your personal enrollment. **This link expires in 30 days.**
3. You will be asked to verify your identity for security purposes. Please input your email address and the last four digits of your Social Security Number.


The screenshot shows a light gray form with two input fields. The first field is labeled "Email..." and the second field is labeled "Last 4 of SSN...".

4. Click in the box next to "I'm not a Robot."

6. Once successfully verified, you will be presented with the Consent page. Click "Save and Next."

7. Complete the information in the **Worker Info** tab. Once the completion percentage is at 100%, as displayed on the navigation on the left side of the screen, click "Save and Next" at the bottom of the screen.

8. Complete the information in the **Additional Info** tab. Once the completion percentage is at 100%, as displayed on the navigation on the left side of the screen, click “Save and Next” at the bottom of the screen.
9. Complete the information in the **Banking Info** tab. Once the completion percentage is at 100%, as displayed on the navigation on the left side of the screen, click “Save and Next” at the bottom of the screen.
 - ✓ If you select EFT, more fields will populate. Ensure that these fields are completed 100%.
 - ✓ If you select Prepaid Card, download the Money Network form at the end of the enrollment and submit to Palco to receive your Money Network card. Your enrollment will not be completed until the Money Network form is received.
10. Complete the information in the **Withholding Info** tab. Once the completion percentage is at 100%, as displayed on the navigation on the left side of the screen, click “Save and Next” at the bottom of the screen.
 - ✓ Complete the Federal Withholdings section the same way you would complete an IRS Form W-4.
 - ✓ Select the appropriate option on the FICA Withholdings section.
 - ✓ Complete the State Withholdings section the same way you would complete a Kansas Form K-4.
 - ✓ Select the appropriate option on the Exclusion from Overtime Pay section.
11. Navigate to the **I-9 Data** tab.
 - ✓ Select the appropriate option under Citizenship Status.
 - ✓ You are required by U.S. Department of Homeland Security to submit supporting documentation to the I-9. Consult the list in the below link to determine which documentation you will submit.

- ✓ Select the appropriate response to the Citizenship Documents box.
- ✓ Complete all required fields.
- ✓ Upload and submit supporting documentation at the following location(s) on the page.
 - Make sure that the document is one of the approved file types, as specified.
 - Make sure that the document is 450KB or less in size.

***Upload New File (accepts .jpg, .jpeg, .png, .gif, .pdf - up to 450KB in size)** No file chosen

12. Navigate to Signature tab. On the “Add New Signature” box, hover inside the box. Your cursor will change to a T-shape. Using your mouse, click inside the box, hold down the button on your mouse, and create your signature by dragging the mouse.
 - ✓ When done, click “Apply.”
 - ✓ The signature will then display in the “Current Signature” box. You can redo the signature as many time as you need to.
 - ✓ Once the signature is complete, ensure it is in the “Current Signature” box and click “Save and Next.”



13. Proceed to each form. Read the forms entirely.
 - ✓ Ensure that all appropriate fields are prepopulated with your information. If not, please go back to previous tabs and correct the information by updating and clicking “Save and Next” on that tab.
 - ✓ Read the notice at the bottom of the screen and click “Apply Signature.”

By clicking "Apply Signature", you agree your electronic signature is the legal equivalent of your manual signature on this document and that you agree to abide by the terms of this document. Once you apply your signature, click "Save and Next."

- ✓ Ensure that the signature applies to the form before proceeding. Then, click “Save and Next.”

14. Make sure all tabs show 100% and then navigate to the Summary tab.
 - ✓ Ensure that the completion is at 100%.
 - ✓ Any fields or forms requiring attention will be denoted with a red star. These items must be completed before submitting your enrollment.
 - ✓ If you are satisfied with the enrollment, click “Submit Enrollment.”

15. When the following box appears, you are complete. Please note the option to download various informational forms, as well as the forms that you completed and signed during this enrollment.
