

Idaho "Cost To You" Worksheet

As an employer, the cost of hiring employees includes paying wages and payroll taxes. Palco charges you at your **individual** employer rate giving you the potentially <u>cheapest</u> rate for your individual situation.

- ✓ Your SUTA rate varies depending on your employer's experience. Your rate is not blended with other employers, and you are able to fully take advantage of any SUTA rate decreases.
- ✓ Your employer tax rate varies depending on the attendant's relationship to the employer. You can take full advantage of individual tax exemptions, so more money goes into the hands of your Employees!

Multiply your employee's hourly rate by the percentage to determine your employer cost to you amount.

Example: \$15.00 x 1.0419 = \$15.62

The table below illustrates the cost for a new employer at 9.48%. You should use an <u>individual percent</u> that meets your circumstances and multiply the rate by that percent. **Support Broker Maximum Rate
