



# **Enrollment Letter - New MexiCare**

#### October 20, 2025

To complete Palco Enrollment, it is essential that both participants and caregivers, whether new or existing, have an **individual email** address established.

### **NEW ENROLLMENTS**

To ensure your services transition effectively, both the participant (i.e., employer) and caregiver (i.e., employee) will need to complete enrollment packets. These packets are critical to ensure Palco can become the employer agent for your services so that your employee paycheck is correct.

If you enroll today, Paid Services will start on 12/21/2025.

For your convenience, Palco has a Participant/Employer Enrollment Packet and a Worker Enrollment Packet posted to our website. You must enroll before 11/28/2025 to avoid any disruption in your services! Once you complete your enrollment packets and Palco processes them, you will receive a welcome notification email with start date from Palco with your Palco IDs and important program information.

# **EXISTING ENROLLMENTS**

To ensure your services transition effectively, both the participant (i.e., employer)/employer and caregiver (i.e., employee) will need to verify the accuracy of their information in Palco's system. These verifications are critical to ensure Palco can become the employer agent for your services so that your employee's paycheck is correct.

For your convenience, Palco will issue an email with your credentials to log in to our system and verify your information. Participants and caregivers will receive notification via email from Palco by November 15, 2025, with important information regarding your new enrollment paperwork. You must enroll no later than 11/28/2025 to avoid any disruption in your services! Your last service date with ARIS will be 12/20/2025 with pay date on 12/26/2025.

If a payment is issued by ARIS, then they will be responsible for reissuing the payment if the item is lost or stolen. ARIS will not process any timesheets after 12/22/2025.
